Re: Department Handgun Purchase

The Department purchased our current handguns: Glock - .40 caliber - Model 22- 4th Generation in March 2010.

The handguns are now 10 years old; these firearms are exposed to all weather conditions and general wear and tear, the weapons are carried by the officers daily.

Officer and public safety are paramount, and these weapons are required in order to carry out that task.

In keeping with our 5 year planning and 10 year replacement cycle on Department firearms, I recommend trading the current 16 handgun firearms in for the Glock-9mm Model 17- 5th Generation.

The 9mm is currently the industry standard.

The Department has taken in 18 firearms, these firearms were converted to Police Department property by petitioning the courts and firearms relinquished to the Department. I recommend that we use these firearms also towards the purchase.

I also recommend selling the Department's current 40cal ammunition inventory.
