**Re: Rock Salt Antitrust Litigation Settlement Fund Distribution**

Dear Chuck Walder:

Earlier this summer, I announced an \$11.5 million settlement with Morton Salt Inc. and Cargill Inc. to resolve allegations that the companies conspired with each other, causing state and local governments to pay higher prices for the rock salt used to make icy roads safer for travelers. When I announced the settlement, I indicated my intention to return a significant portion of the money to local agencies and governments who buy rock salt. Over the summer, my office processed claims from 850 Ohio public entities, including your claim.

I am pleased to present you with the enclosed check in the amount of \$2,006.33 as a distribution of settlement funds from the Rock Salt Antitrust Litigation. I know that you, and others like you, stretch public funds and taxpayer dollars as far as possible to benefit your constituents. I hope this share of the Rock Salt settlement fund helps you make roads safer for the citizens that depend on you. Be assured that my office will continue to investigate and take action to ensure a competitive marketplace and to safeguard taxpayer dollars.

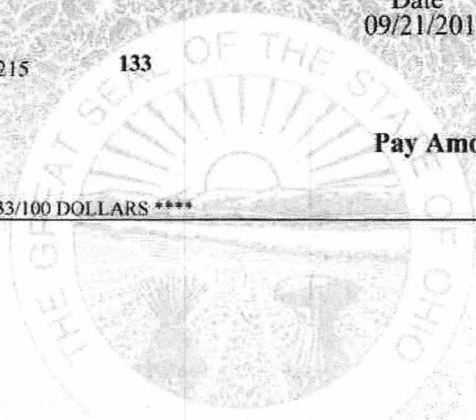
