The following quote is for snow removal and deicing services to be performed from November 1, 2015 to March 31, 2016. Snow will be cleared from parking lots and walkways when a depth of two inches has accumulated. Walkways will have deicer applied each time they are cleared. The administration building, located at 8501 Kinsman Road will be serviced during regular hours of business. The police and fire stations will be serviced as needed 24 hours per day, 7 days a week.

Salting of parking lots is not included in the seasonal service price and is priced per application. TRC recommends that salt be applied each time lots are cleared. In addition, salt can be applied at request when snow has not accumulated to two inches.

- All work will be performed as specified on plans, or this quote


All work is to be provided using industry standards and executed in a professional manner. TRC shall be responsible for damage done as a result of providing plow and salt service. In addition TRC will repair any damage by May 1st or as weather permits. We will mark any areas of concern after meeting with you and prior to any snowfall. Any damage must be reported to TRC prior to any repair work done. TRC shall have the right to repair any damage "in house" or contract a qualified person to perform repairs. TRC will not be responsible or pay any bills related to repair of damage that has not been looked at by TRC.

No deposit is required for work to begin. Customers with established credit will be invoiced at the beginning of the month for services rendered in the prior month. Terms for these clients are net 10 days from date of invoice. All balances older than thirty (30) days shall be charged interest at the rate of 2% per month (24% per annum) and Client agrees to pay same.
