WHEREAS, The amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said ³

Township of Russell, Geauga County, Ohio; therefore be it

RESOLVED, by the ² Board of Township Trustees..... of the Township of Russell, Geauga County, Ohio, two-thirds of all members elected thereto concurring, that it is necessary to levy a tax in excess of the ten mill limitation for the benefit of

for the purpose of ⁴ providing and maintaining motor vehicles, communications, other equipment, buildings, and sites for such buildings used directly in the operation of a police department, for the payment of salaries of permanent or part-time police, communications or administrative personnel to operate the same, including the payment of any employer contributions required for such personnel under section 145.48 or 742.33 of the Revised Code, for the payment of the costs incurred by townships as a result of contracts made with other political subdivisions in order to obtain police protection, for the provision of ambulance or emergency medical services operated by a police department, or for the payment of other related costs, as provided in ORC ~~795.19~~ ^{19.06} mills for each one dollar of valuation, which

amounts to ten cents (\$.10) new, additional tax of 1.00 mills for each one hundred dollars of valuation, for⁵ a continuing period of time, which levy is a
