Resolution 2020-13

The Board of Trustees of Russell Township, Geauga County, Ohio, met in special session on the 6th day May, 2020, at the Town Hall with the following members present: Kristina Port, Gary Gabram, and James Mueller.

WHEREAS, a 1.8M levy was most recently renewed in 2017 for the purpose of the general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges. Monies collected from said levy are currently paid into Road District Fund 2141;

WHEREAS, a 2.75M levy was most recently renewed in 2018 for the purpose of the general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges. Monies collected from said levy are currently paid into Road District Fund 2141;

WHEREAS, a 1.1M levy was most recently approved in 2013 for the purpose of the general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges. Monies collected from said levy are currently paid into Road and Bridge Fund 2031;

WHEREAS, a 1.4M levy was most recently approved in 2016 for the purpose of the general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges. Monies collected from said levy are currently paid into Road and Bridge Fund 2031;

WHEREAS, all of the above described levies were approved for the same purpose pursuant to R.C. 5705.19(G);

WHEREAS, for more efficient management of the funds from these levies, the Board wishes to have all collected monies flow into one fund;

WHEREAS, the Board wishes to redirect all future monies collected from levies currently paid into Road District Fund 2141 instead to Road and Bridge Fund 2031;

WHEREAS, the Board wishes to leave any previously collected monies in Road District Fund 2141, to be appropriated and spent in the usual manner until Road District Fund 2141 is depleted. Once the balance in Road District Fund 2141 is zero, the Board wishes to close this Fund;

**NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF TRUSTEES OF
RUSSELL TOWNSHIP, COUNTY OF GEAUGA, STATE OF OHIO:**

The Board wishes to redirect all future monies from the 1.8M levy most recently renewed in 2017 and the 2.75M levy most recently renewed in 2018 to Road and Bridge Fund 2031 and to leave any previously collected monies in Road District Fund 2141, to be appropriately spent until Road District Fund 2141 is depleted and closed.
